Stephanie W was elected as the Panel Coordinator. We need volunteers for this facility. The population of this facility is all young women. Our volunteers need to be at least 21 years of age. We have several other facilities that would like a meeting brought in including Douglas County Jail, Rite of Passage (youth facility) and 3rd Way (another adolescent facility).

As always, we are in need of volunteers at all levels. We need Panel Coordinators at Denver County Jail – Men's, Denver Health and Jefferson County Jail – Men's. We need panel members to go into several of our existing facilities as well as to help us with the new facilities that are requesting our support. I urge all GSRs and others present here today put the word out. **WE NEED VOLUNTEERS!** We are in special need of female volunteers and younger members of the fellowship. We are still looking to fill our training coordinator position. I ask that the GSRs make a special effort to get the word out. H&I is a very easy, very non controversial way of helping to carry the message to the addict that still suffers. Not that we need to compete with AA in any way but they are able to provide H&I meetings in a lot of facilities that we don't. I am also going to suggest to the subcommittee that we create a new position of H&I Recruiter.

I would like to coordinate a "Service Extravaganza" with the other subcommittees sometime after CRCNA. This would be a means for members of the fellowship to learn about many of the service opportunities available. I am asking for suggestions from any member of the fellowship about how to get and keep people interested in H&I service.
