Two main speakers have been confirmed (Carlos G from Denver and Bob G. from Ohio.) The third (Gina B. from NYC) is still in the process.

This is my first report to the area as Chair for H&I. I want to let you know that I am honored to be of service and I am humbled at the privilege. H&I has been my passion for many years and I truly believe that the newcomer, people coming out of rehabs, hospitals, and institutions, are the heartbeat of narcotics anonymous. Not only that but when you participate in an H&I meeting you get back 1000 times more than you give. I invite all GSR's of all the mile high area meetings to carry the message to their home group

members, who have 6 months or more clean time, to come to the H&I training on Sunday July 8<sup>th</sup> at 5:00P right here at 1212 Mariposa. This commitment is as little as an hour a month and I promise you will be grateful you did, it is an awesome way to give back and to stay clean! There are certain facilities that we are not able to go as scheduled due to lack of volunteers ie Jefferson County Men's and The Federal Correctional Facility in Englewood. These do require more clean time and a background check and we do need help desperately so please pass the word. We are also looking for Panel Coordinators for Parker Valley Hope and The Phoenix Center and a new woman's facility that still need to be started.

Now on to the updates of our subcommittee, we met last month on June 10<sup>th</sup> with 15 in attendance. I had help from Jay M. whom I am so grateful for. He did a great job as chair this past year and unlike some chairs of the past he is actually staying plugged in and helping in many areas of H&I. He is going to be continuing his work on reviewing the Literature needs of each facility so we maximize our budget. We are also looking forward to participating with CRCNA XXI and Alan F. has stepped up to the plate to be the contact person for H&I. We have also started the process to create a new position within H&I which will be called the New Volunteer Coordinator. This person will help new volunteers get attached to a facility that works for them, and not fall through the cracks and disappear. We will update the area as to how that is working and ask you to expand our guidelines as needed at that time. I am very excited about this as we have needed a way to ensure we don't loose good volunteers. Thank you Billy for all your help on this project! I am very proud to announce that we do have a new Vice Chair, Valery M. was voted in at our last meeting. She has been the H&I Secretary and has done a wonderful job and I am sure she will be awesome in her new position! I know she will make me look good even when I get overwhelmed.
