RCM I Joseph B.: I attended the Colorado Regional Assembly in Loveland on July 14th. There were 24 GSRs in attendance. 5 from Boulder, 7 from mile high, 9 from off the wall, and 3 from Pikes Peak. Boulder has reestablished its H&I meeting in the Adams county jail. The committee went 4 months without holding that meeting due to lack of participation. Boulder is currently without a second RCM and a phone line chair. Mountain high now has two RCMs and has added another meeting in Craig. Attendance is low in Steamboat but the meeting is still open. Off the wall area is excited about hosting CRCNA 22 next year per the rotation schedule since no other area showed up with a bid. Pikes peak is hosting their 10th annual pig smoke Sunday September 9th starting at 11am at Memorial Park. Activities will include tug o war, fishing, swimming,

and a raffle. Call veta @ 719-392-1969 for questions. Pikes Peak is also the location for a statewide professional symposium on addiction and behavioral health. The World Service Office has paid for the booth, literature, and a World board member to come to the springs and represent NA during this time. This symposium will be held August 6th through the 9th. Serenity unlimited area hosted the Rocky Mountain zonal forum July 28th and 29th in Grand Junction the discussion topics and workshops held by the World Board members in attendance were on building strong homegroups and building strong homegroups in isolation. Serenity unlimited is also hosting the Standing on higher ground campvention August 10-12th in Telluride, details on www.nacolorado.org . Brenda E. was nominated and elected Regional Delegate Alternate position, Linda L. received a world board nomination that will be sent from Colorado to this years conference. It summarizes, clarifies, and updates parts of The Group Booklet. Group Business Meetings This is a resource to help groups conduct their regular business. It includes ideas for groups to consider, including a sample business-meeting outline. All of these service pamphlets will have a different look to distinguish them as service materials. When they are released, please be sure to give us your thoughts about them. Also, continue to send us any ideas you have for other new service-related topics. Public Relations Handbook update The initial twenty-eight PR Handbook chapter resources have been completed. These resources include addenda for chapters two, four, five, six, seven, nine, and eleven. With the new position of new volunteer coordinator we should be able to streamline them into a facility that is right for them. I want to let you know that many of the volunteers we get are new in recovery and for that I am grateful but we really, REALLY need volunteers with 2 years or more clean time and off paper for 2-5 years, that can pass a background check. We missed going into Jefferson County Jail on Thursday, July 5th due to lack of volunteers who are cleared. I can not stress enough the

need we have and the satisfaction you will receive by giving back to addicts who might not otherwise ever hear our message. So please, PLEASE take this request back to your home groups and bring us a list of addicts who can help!

Also with the fast approach of CRCNA XXI we will be in need of volunteers to help with H&I registration at the convention. There is no clean time requirement to help at the H&I check-in and there will be a sign up sheet in September for 2 hour blocks. Also if you know of any facility in your area that you want contacted you need to let us know ASAP! We are starting to contact all the facilities on our list as of August and I have only received 2 requests from the fellowship so far. I know that the still suffering addict is the heartbeat of Narcotics Anonymous and that starts with H&I.
