The H&I Subcommittee met on October 14 with 11 people in attendance, it was cold and rainy so we appreciate the ones who dared to go out. We had a great amount of excitement in the air, with CRCNA XXI around the corner. There had been a great deal of effort put into the H&I Play that was held at the convention. I must say that it was a hit and from that play we got a list of at least 15 volunteers to come to the H&I training.

Speaking of the training, I have brought flyers for all the GSR's to bring back to their home groups. The training is right here at 1212 Mariposa next Sunday November 11, at 5:00pm. We have new facilities that are waiting to be opened, we just need the volunteers. We are also in need of a Panel Coordinator at the Salvation Army Men's which meet on Tuesday evenings. Also for the women we need some volunteers for the Moms House, which meets on the 1st and 3rd Thursday each month. Both of these positions do not require any background check, just 6 months or more clean time. Like I've said before you get back 1000 times more than you give and we only need you for an hour a month. Discover the high in H&I and come join us.

Now speaking of high in H&I, I was thrilled at the turn out from the hospitals and institutions at CRCNA XXI. We had record breaking numbers with 110 registering through H&I. I believe that is how we determine the success of the convention is by how many newcomers get to experience our new way of life. I was honored to be able to wrap the newcomer tablecloth around the person with the least amount of clean time at the clean time countdown. I can't put into words the emotion that I felt reaching out to that person with just 24 hours clean! That is what this program is all about- giving that spark of hope to a still suffering addict! All I can say is wow!!!

That is the same experience that you can expect to receive when you donate an hour of your time a month and help us carry the message of Narcotics Anonymous through H&I.

I want to recap what is happening with Denver Drug Court. We have now 2 people stepping up as Panel Coordinators to make sure that the meeting is appropriately represented, along with literature and meeting schedules. The meeting is the first Tuesday of every month at the Denver City and County Building at 6:00pm. It is set up with 2-3 speakers and time for a few questions and answers at the end. I for one am jazzed about the possibilities of helping addicts who would have not had exposure to NA, but through Drug Court. Finally the judges and magistrates and the quote unquote politically correct people in our government are catching onto the fact that by forcing these people to get clean is not what keeps them clean. It takes plugging into others that are staying clean to make it happen. One addict helping another is without parallel.

All phone line shifts are covered at this time. It was brought to my attention that there was no way of returning to the main menu after any given option was selected on the voice mail system. After talking with Dale @ Golden Voice the appropriate changes were made, and a prompt is offered that will return the caller to the main menu.

I participated in the phone line workshop at CRCNA XXI this past weekend. Although the attendance for this particular workshop was relatively low, I found it very enlightening to hear other addicts' experience with phone line service.

I would like to thank Alan T. for introducing me to James C. from Southern California. James is an addict who has extensive experience with developing his area's phone line. We discussed many issues, and exchanged contact information. I think his experience will be very useful in the consideration of a regional phone line here in Colorado. I will share the information I have gathered with Joseph B. who is currently chair of the regional ad-hoc committee that was formed to explore the feasibility of a regional phone line. If the region chooses not to move in that direction, I am hopeful that the Mile High area will consider adopting some changes to the current phone line service. It does not seem necessary to elaborate on possible changes at the area level until after the regional ad-hoc committee presents it's findings.

On October 16th we manned a table at the Broomfield Library from a request of the Broomfield County Health and Human Services Department. I had to borrow literature from CRSCNA PI to accomplish this task. I am submitting a request for literature reimbursement for the CRSCNA PI.

Mile High PI also had a request for speakers that was set up and fell apart on October 30th at Thomas Jefferson High School. It was a number of different things that created this screw up. On November 1st we had two different speakers fulfill a request from Montbello High School. They each spoke and then had a Q & A with the students who responded with numerous questions. We also spoke with a teacher and referred her to some meetings in her area for her son. It was a great success and helped us to overcome our mistake from two days earlier.

PI has not had a meeting since June 2007. There are various projects that we could be accomplishing if we were to meet. ie. Poster hang with homegroups, bus placards, and the 9 Health Fair.
