Nomination Training Chair Torri nominated. Accepted and voted in.

Nomination for Assistant Treasurer Pat possible wave of clean time requirement of four years to two; NA has this guide line and two addicts concur with this wave. Mack stated that there is a clean time requirement and they are accountable for the money but willingness and ability can be an over-riding factor for the lack of clean time; Pat has the experience in this area. Torri: Some things just aren't negotiable like our traditions some things are hear-say some are factual, we are dealing with our money; willingness or not is just not enough, a warm body when is that just not enough for us anymore? We need to grow up and stop filling it with warm bodies and someone that has the time and the experience to fill the position; recovery is based on recovery and based on spiritual principles that not on our disease, let's not fill our positions like this.

Sammie spoke about things doing the position as primary she explained how she came up short and after to make everything better, but at the time she was in a panic but it was a bank error not her own. Pat declined the nomination no vote was made.

New business

Lindsay B and Spence – Pay for CRCNA registration for the winning design: passes

Lindsay and Bob P: donate 10 solutions T-Shirts for raffle

Torri: How many do we have and what is their worth and why have they not been made available for the area before.

Lindsey states that they are worth \$5.00 each but yes we have X of each size just not sure how, Torri wants an official count by next area and maybe we can sell them for \$10.00. Lindsay thinks as an area we should not decide, but as activities we can and there will be an inventory next month.

Joann D and Bob D: proposal to change the guidelines under budget article X, to read as follows: the deletion of the emergency fund and must be adjusted to the needs of the next three months, budgeted contractual obligations have to be set up in quarters. This requires a 2/3 vote and it means we have our phone line and it costs \$400.00 and the contractual obligation to them is \$100.00. Also to remove more verbiage from the emergency fund and it cannot be used only for contractual obligations and nothing else only when there is no other money available to pay for them.

Keegan is not comfortable voting on this without taking this back to his group; he also feels that there is too much on a full plate that does not need to be here.

Joann pulled the motion and is going to give it to the ad-hoc.

Ron T and Daryl M: Donate the group pamphlet to outreach so that we can take some literature and material to groups that are not represented at the area. The intent is to use this and other pamphlets as a welcoming format to new groups that are not part of or familiar with the areas ability to support groups in being more efficient. Tabled by Ron

Motion by Joann D and Spence: H&I change the guidelines that members that serve to carry a clear message while using prescribed narcotic and or under an extreme traumatic life circumstance has changed.

Pro: Michelle W. how can you be the best you can be if on narcotics? Michelle is in favor of this vote.

Torri: Being a part of P&I She understands being under the influence and doing a presentation can put NA in harm's way; the same applies for H&I. As far as the life circumstance personally I think that is a very wrong perception of this problem. There is a testament after her son had a bad medical issue this did not affect her ability to serve NA, and maybe NA could have helped her in the end like most service work tends to; she was still able to perform to her abilities. No on traumatic life event.

Robby: Agrees on the narcotics end disagree 100% on the traumatic life event.

Joann agrees on the Narcotic part, not the traumatic life event as the creator of this motion I will withdrawal the traumatic life experience, after which Torri and Robby are 100% behind it.

Mike H. I have a few technical problems with this, does this mean admin or sub-committees but does this imply that activities can't have any one that is using a narcotic medication. Does this mean opiates? What exactly does this mean? Are we going to define this or not?

Brian: Having attended the world work shop last year as this was being formulated, but the temp was rising fast it had to stop. Is this now approved literature? If someone is unstable can they may be unsuitable for service. I am not pro someone high on a script but there are some non-narcotic meds that can be just as bad.

George: This rubs me the wrong way in every way and it is just a suggestion that the member stay away from this until this is over. I do not want to be a part of this if it is in black and white, this is a slippery slope and it should lie between the sponsor and sponcee.

Joann: The back ground as to why I am a pro the area wanted to go in as a representative of NA that was on methadone and H&I started to look for some direction on what to do in this case. The reason that it is stated as a narcotic med, we are not doctors or anything of the sort but we were looking for a direction in how to deal with this, and they may in fact be the most mind altering of all drugs. When we do service work and wither we like it or not we are representing NA and what if you're an addict and you are on xyz pain med and someone asks are you taking meds? Are you to lie or do you tell the truth?

AREA PLANNING TOOL AD – HOC REPORT

The Area Planning Tool Ad Hoc met on July 16th. We completed Step 5 Creating Approaches (actions to reach goals) “An approach describes how to reach a specific goal – what steps an area has to take to achieve its identified and prioritized goals. The plan to reach a goal takes into consideration all current area efforts, the information that was gathered from the groups and area inventory sessions, and new ideas, In the interest of simplicity, members may want to limit the number of steps to achieve each goal to two or three.” – Area Planning Tool

Based on Step 4 these are our findings.

1) Guidelines – (Review and Rewrite)

A) Articles I-VI and VIII-X will be the responsibility of the Administration and Ad-Hoc Committee.

B) Articles VII and Subcommittee Separates will be the responsibility of the Subcommittee.

C) Include overlapping terms for trusted servants as described in the PR Handbook pg.26 Communication and Effective Services

D) Decide on a single method of voting for specifics.

Roberts Rule of Order VS Consensus Based Decision Making

E) Housecleaning – to include all changes that have been made recently and delete those that are no longer valid.

At the end of the Rewrite the guidelines will be distributed to all homegroups for approval. Any addicts willing to participate in any part of the review or rewrite process are welcome.

2) Training and Mentoring

A) Elect a Training Chair

a)GSR Trainings prior to ASCs

b) Regularly scheduled learning days

c) Teambuilding Exercises during ASCs

d) Overlapping term to train next chair

B) Keep with established Mentoring project

C) Area support available for train group level trusted servants

D) Have feedback for groups to bring back to Area. Pose a question each month or every other month and discuss during Open Forum

3) Willingness and Humility to ask Region and NAWs for help/suggestions

A) Also other areas for experience, strength and hope

B) Region's experience with CBDM

C) Stay current with literature and workshops

Our next meeting will be August 6th at 6pm. We will be completing Step 6 Prioritizing Approaches (a second look). This is the last step before we solidify our plan. This has been an insightful and amazing process.

Mile High Area H&I Subcommittee Chair Report August 3, 2008

The H&I Subcommittee met last on July 13th with 21 in attendance, which included 10 new volunteers who came for training. All the newly trained volunteers were assigned to a facility by the end of the meeting and are ready to begin service work through H&I.

We currently take H&I meetings into 24 facilities, two of which have asked for additional weekly meetings to the ones we are already holding. There is still a need for male volunteers at Jefferson County Jail and both men & women at ICCS and Denver Cares. There are Panel Coordinator openings at Marvin Foote Boy's in Centennial and Peer One Outpatient in downtown Denver. Additionally, we are currently holding talks with the program directors at Camp George West, the Wright Center, Marvin Foote Girl's Side, and Douglas County Jail to begin new meetings in these locations. Needless to say, we need more volunteers. I appeal to everyone present here today to take back to your home groups and other meetings you attend the need for H&I volunteers. Remember, we can only keep what we have by giving it away, and there are so many suffering addicts who need to hear the NA Message.

If you are interested in H&I service work or want to learn more about what H&I does, please join us next Sunday, August 10th at our subcommittee meeting, right here at 1212 Mariposa at 5pm. If you have six months clean time you are able to go into 17 of the 24 facilities we currently serve. The correctional facilities and jails generally require 1-2 years off paper and a background check. I encourage anyone interested to also consider going in as an observer or guest speaker to one of our non-DOC facilities.

Many members of the Mile High Area H&I Subcommittee along with H&I members from other Colorado areas have applied and been cleared to begin the training process with the State of Colorado Department of Corrections. The first training for these volunteers will be held Sept. 13th at the Denver Women's Correctional Facility. This regional effort combines H&I members throughout the state to be able to take the H&I message to the prisons and correctional facilities in Canon City and other outlying areas.

The Mile High Area H&I Subcommittee will be present with our sign, new volunteer sign up sheets and informational packets at the CRCNA XXII Luau & Pig Roast in Boulder on August 2nd, the Labor Day Picnic September 1st, and at the Chili Cook-Off and Talent Show on September 20th.

Regional Committee Member Report

August 3, 2008

The Regional Assembly went well. On Saturday we had a good turnout for the Learning Day activities. Experience was shared on the topics of Traditions 1 – 7 at the Group level and Tradition 6 – 12 at the Area level in the morning session. Our RD & RDA were able to present a partial workshop on Leadership in Narcotics Anonymous.

On Sunday the Regional meeting was attended by 19 GSR's and GSRA'S with 5 being from the Mile High Area. The Vice Chair reported on the options available currently for phone services within the region. The proposal from the previous meeting was addressed again in old business; asking to provide an information line and phone service to Area's that currently do not have service if it is requested by the Area. This proposal was tabled once again in order to present the cost to the Areas for consideration. There is a one time set up fee of \$100.00 and \$15.00 per month for maintenance. Some discussion that transpired was information being vague, there are no guidelines, and it was pointed out that this proposal was just to make the line available to an Area if they decided to use this service. The Vice Chair also brought up discussion concerning the possible formation or use of a Public Relations subcommittee. This brought about the same discussion points from the April assembly. As a result the Chair has appointed another ad-hoc committee to reinvestigate this tool.

Public Information presented a nomination for a new chair of Tawni C. She was not present therefore could not be voted in. One proposal presented by this committee is to make Outreach a standing subcommittee of the region.

H & I is making strides on getting DOC clearance for members to go into Sterling and Canyon City. The committee is in need of male volunteers. There was discussion about using JPal to do correspondence with inmates from some of the Federal prisons.

Brenda E. is now our Regional Delegate and will be attending the Rocky Mountain Zonal Forum. The RDA position remains open. We created a new CRSC Budget standing subcommittee. CRCNA guideline changes have been approved. Colorado Springs brought a bid to host CRCNA next year and was awarded the bid. We will have more information soon as they already have three bids to choose from.

Other areas are doing well. The Pikes Peak Area has begun an Outreach subcommittee and has begun to do some letter writing to inmates in the institutions in their area. I received a name and phone number that I will be passing onto our Outreach subcommittee.

I would like to thank the Area once again for making it possible for me to attend the Regional Assembly and I have returned 22.81 to the treasure, along with my receipts. Many who were in attendance went to a Saturday night meeting and we had great fellowship.
