I produced 5000 MHA meeting lists this month. I will distribute these so they last a full quarter.

The total a cost was \$280 which is almost half the cost per list that we used to spend. We will have more meeting lists available than before at a lower cost. We would have spent \$332 for 3000 or \$410 for 4500 over the next quarter by printing them in smaller batches each month.

This did put me \$56 over my current quarter budget since I had already produced two earlier printings. I will be asking for a disbursement this month to cover that difference. The website budget request will be reduced again this quarter to \$280, down from \$350 last quarter, and from \$450 the quarter before that.
