There are currently 56 groups in the MHA. They hold 112 meetings per week. We list an additional 6 meetings from nearby areas on our meeting list for a total of 118.

The website email (milehina@nacolorado.org) received 4 requests for meeting locations in the last month. One, from an addict in a wheelchair with limited ability to get to meetings, was forwarded to the Outreach committee. Some of these requests were also seeking support through email. I encourage them to get to meetings, use the phone line, and ask women to respond to the women asking for help. It seems to me that in the last few months the number of attempts to

seek contact through email has been increasing. The website committee may need to work with Outreach and Phone line to determine appropriate guidelines for handling these requests if they continue to increase.

I have been getting training information to Nick A., the nominee for website chairperson. He has successfully accessed the website source code and been taking on some duties of the website committee in the last month.

The website subcommittee met last month to review the continuation of all ongoing projects including; Mobile phone formatted meeting list – While some promising progress has been made, this process is still underway and will be reviewed again when it is closer to completion.

2) Responsibilities for working with NAWS in the 'Web Contact' capacity – It was determined that I would sign up with NAWS as the Web Contact person for the MHA. I will review the capabilities they offer for more automated updates to the NAWS meeting database. I will also be looking at this from the perspective of Regional Website Chairperson, a position I now serve in. I will be attempting to simplify the process of maintaining up to date meeting lists at the area, regional, and world level with the goal of having updates occur in fewer places and automatically flowing to the various databases and displays.

3) An email portal for standardized email address for admin members and subcom chairpersons. - I am still investigating the technical requirements for setting up an email portal site that would allow simplified training requirements for all subcommittee chairs and admin members to have uniform email addresses using the nacolorado.org domain. i.e. mhasc.treasurer@nacolorado.org
