The next Outreach Subcommittee meeting is on Sunday, August 8, 2010 at 2:00 PM, 1212 Mariposa St., Denver, CO 80204 (That's the community center across from Lincoln Park--3 blocks S of Colfax, 3 blocks W of Santa Fe Dr.). Everyone welcome!

We have many opportunities for service, big and small.

We are looking for folks to make one-time visits to meetings struggling with trusted servant issues and attendance problems to see if area can help them. If you want to expand that one-time service into something more long term, Great!

We have many programs to work on. Some of the programs are well established and we are trying to expand them. Some of the programs are so brand new we don't know what they will really be like in their up-and-running form. Whoever steps up to help move these new projects forward will contribute their vision and direction.

Also, the Outreach Subcommittee is looking for a treasurer, a vice chair, and a secretary.

Just some of Outreach's tasks and ideas that are in one stage or another of implementation:

- Reach out to meetings not sending GSRs to Area and ask what area can do for them. Invite them to be involved with area.
- Help new and struggling groups through the Adopt-a-Meeting Program. This effort needs everything from a program coordinator; to a flyer designer; to someone to hand out coupons and start-up kits at area; to folks who will explain how the program fulfills its mission.
- Learn how to start and run a teleconference meeting.
- Liaisons from Outreach to both the Public Info and Hospitals & Institutions Subcommittees.
- Explicitly invite GSRs to suggest the direction or vision they believe the area should have.
- Contact, advise, and support detached (area-less) meetings in the Colorado region via email, snail mail, texts, road trips, workshops, and unity days, etc.
- Contact Outreach committees in other areas and regions and see what they are up to.
- Shadow roll call, hand out startup kits and coupons to GSRs at area.
- Help addicts make the transition from institutions to the rooms of NA.
- Create some mini-inventory details of the area and have those members that are not as verbal as some of us to be able to voice their group's positions.
- Expand the Correspond with Inmates program into more institutions in the local area.
- Coordinate poster days in neighborhoods of meetings looking for support.
- Continue to update the WSO's database by working with the Web Contact Person.
- Advertise chat rooms and conference call mtgs via flyers, website, etc.
- Update the Outreach webpage in coordination with the webservant. (Make it relevant to the programs we've got going, include a blog, include a virtual suggestion box, etc).
- Update Outreach's guidelines to reflect new and changing functions.

Adopt-a-Mtg

Meet'n Up North is experiencing a steady attendance of young female newcomers. Therefore we are inviting women with a strong message to attend that meeting whenever you can to share your message with the young female newcomers.

Meetin Up North meets Thurs at 7:30 PM at 3101 E 100th Ave.

Directions: If one got off I-25 at 104th and headed E, one would come to Steele. Go south 4 blocks to 100th. The church is on the NE corner. The W parking lot is most convenient. The entrance to the meeting room is thru the garden level "glass wall" on the W side of the church.

Outreach is supporting A Wake Up Call in Adopt-a-Mtg. A Wake Up Call meets Sundays at 9:30 AM at 121 Acoma St.-- one door N of 1st & Acoma. There is a \$3 breakfast sponsored by the facility served from 8:00 to 9:00. We are passing around a sign-up sheet for you to sign up for a ONE TIME commitment to attend.

We continue to rethink what the Adopt-a-Mtg Program does and how it does it.

We are looking at working with the Training Subcommittee to give trusted servants of struggling meetings information about how to reach out to other NA members, to make their meeting more attractive, build their home group membership, fill out the meeting's slate of trusted servants, and build the meeting's attendance to larger numbers.

Also, we are looking at inviting NA members to choose a home group and to be of service there.

We are considering organizing with Activities a gathering of trusted servants from the groups that have low attendance and are looking for trusted servants. Everyone would be invited and folks could meet with reps from each meeting and see what they've got going on.

We are working with the Public Information Subcommittee and with meetings looking for support to do Poster Days in their neighborhoods.

Currently we believe that meetings that are placed in the Adopt-a-Mtg Program for 90 days do not enjoy a long term improvement in attendance. (That 90 day traditional form means passing out flyers that invite people to attend the meeting, and get people to sign up for a ONE time attendance commitment. Meetings have a short-term rise in attendance while the meeting is in Adopt-a-Mtg, but afterwards attendance sinks back down to previous levels.

What to do?

One attendee of the subcommittee meeting said he believes that Mile High Area folks often do not choose a home group. Therefore some groups have a shortage of trusted servants. This may result in one person filling several trusted servant roles, no one acting as a GSR, and a weaker message during recovery mtgs.

Those are some of the symptoms of a "struggling meeting." Perhaps this could be addressed by encouraging the folks of Mile High Area to choose a home group and be active in service at that group.

We spoke with Bob D. of the Training Subcommittee about putting together a brief presentation or even a workshop to let people know the advantages of having a home group and letting that be the basis of one's service to NA. We envision that this presentation would be given at the groups either briefly during announcements or at groups' monthly business meetings. The latter makes sense because then the active home group members would have ideas about how to go out and share with others about being a home group member.

Perhaps we can coordinate with the training program to cultivate a better attitude for service among the groups.

We discussed the strategy of building up numbers of NA members in the neighborhoods around struggling meetings. We would work with Public Info to get literature into the treatment centers near the struggling mtgs. Not sure where the folks in the centers actually live.

Organizing with Activities a gathering of trusted servants from the groups that have low attendance and are looking for trusted servants was discussed. All would be invited and folks could meet with reps from each meeting and see what

they've got going on.

Poster days in neighborhoods around meetings with low attendance were discussed. This would be coordinated thru the Public Info Subcomm. The trusted servants of the several groups would be invited to participate in this.

The Adopt-a-Mtg program is supporting The 5th Tradition Mtg. This meeting meets Fridays, 8:00 PM at 22nd & Lawrence at the Phoenix Concept (no affiliation). There are many newcomers at this meeting w/ 6 months or less of clean time. We continue to get people signed up for The 5th Tradition Mtg. on a one-by-one basis. We invite everyone to attend 5th Tradition whenever you can, and share your message of strength, hope, and experience.

A Woman's Touch is looking for support. It meets 3:00 PM Saturdays, 1450 Airport Rd.--that's a church--no affiliation. A Woman's Touch is child friendly. Also Sisters in Recovery needs support--Thurs 7:30 PM, 1402 Pearl St. and A Woman's Turning Point. Outreach would like to have a woman reach out from the area to these woman's groups and maintain contact with them.

We are talking to meetings with attendance issues and trouble getting a full staff of trusted servants about having poster days in their neighborhoods. PI has seen success with their poster days, and we hope these posters will attract both newcomers and people coming back to the rooms.

Registering Mile Hi Meetings w/ World Services

We continue to register meetings with world. We will soon be giving meeting info to Mike H. who is our Web Contact Person. He can put the info directly into the NAWS database. We recently submitted a registration for Sisters in Recovery.

Meeting Outreach

We continue to visit with meetings that have not sent a GSR to area for at least 3 months. We see how they are doing, and find out if there is anything Area can do for them. We invite them to become active at the area level. There are nine meetings that haven't sent a GSR to area in at least a year.

"Bridging the Gap" the NA Way

This is an idea that Outreach has just started to think about. As clients leave treatment centers after having attended H&I meetings, they are given support guidance and rides to regular NA meetings so that they are made to feel welcome in the NA community.

Outreach had a brief interview with a trusted servant in another 12-step program who has experience with a program like that. He was very happy to speak with us about it. We intend to interview this person and as many NA folks as possible, with an eye to founding a pilot project at least one treatment center.

Fellowship Development and Outreach Program

We are in contact with a new program of the NA Colorado Regional Public Relations Committee called "the Fellowship Development and Outreach Program." The objectives of this program are still being conceived so we invite everyone to share any ideas you have about what such a program might do. The Mile High Area Outreach Subcommittee was contacted specifically about a possible Detached Mtg Program: This Program is still at the idea stage--a great time to get involved. Perhaps the Detached Mtg Program would establish and support a region-wide Outreach program directed at meetings that are so geographically remote that they are not attached to any area.

Teleconferencing Meetings

We are looking into how to start a teleconferencing mtg. Outreach does not start mtgs. As this info is gathered, perhaps someone will want to step up and start one.

Ron T. writes: I have been in communication with Katie B. My interpretation is still at a questioning level. By that I mean: If I was living up in the mountains, where Katie B. lives, it would not be long distance; it would be a local call. Here we are in Denver starting as if it has to be a long distance connection. What Katie and their group found out is that their 7th Tradition. is not able to support long distance. If we are to do this we need to look at this with the two predominant prefixes, 303 and 720, in this area and not long distance.

I have more follow up to do and that looks like going to "meet up group" which is a business that sets up any content meetings and find out their procedure and cost. The second piece is that if we had a 303-720 meeting, how do we let

those who do not attend regularly scheduled meetings know. One thing is to let them know that we have another way for them to get their meetings in. We are looking to set this up for those who cannot attend meetings. I am curious how to advertise, with flyers, posters, and word of mouth. All of these models would help us find out if there is an arena for a teleconference meeting format. What I think from The Bridge Meeting is that we need to attend one of their meetings and find out what we can glean from it and how to continue. If we were to follow what Katie stated it would be two hours or 120 minutes of long distance time. I would be willing to attend if Outreach would buy me a long distance card with 120 to 200 minutes on it. The final word for this report is more research to how to do one and how to man it.
